On 09/20/13, at approximately 10:10 am, I Sgt. Brian Quick received a call from Greg Sandbothe, House of Representatives Operations Specialist, regarding a gun that he had discovered left in the mens restroom on the basement level of the Capitol Building. I made contact with Sandbothe at the restroom which was located directly across from House hearing room # 1, on the basement level of the Capitol. Sandbothe advised he had gone in to the restroom and noticed on top of the toilet paper dispenser a small firearm still in a holster. Sandbothe left the restroom and called me from the hallway to report what was found, while making sure no one else entered the restroom.

At approximately 10:13 am, I entered the restroom and located the weapon in the second stall, sitting where Sandbothe had described. The holster was a black nylon pocket style holster with grey rubber outside. At this time I removed the gun from the holster and rendered it safe. The gun was identified as a Kahr CM9 9mm pistol with serial #102528. The gun was fully loaded with one round in the chamber and six rounds in the magizine. All the rounds of ammuniton were hollow point 9mm rounds. At this time I took the gun and the holster down to the Capitol Police dispatch to have the gun run through MULES to attempt to locate an owner. At approximately 11:47 am, I was advised by Chief Hurt, that the weapons owner David W. Evans, (white male, dob. 04/30/1949) had been located and cleared of any wants or warrants. Evans also had a conceal carry permit for the weapon.

At approximately 12:01pm, I made contact with Evans in the basement of the Capitol building. Before returning the weapon to Evans I verified his conceal carry permit, and asked if he had any paperwork proving his ownership of the gun. Evans stated he didn't have the paperwork with him but offered a very detailed description of the weapon and the holster. Evans was able to identify the weapon by the brand, caliber, color, size, the holster and the ammunition count and type that was in the weapon. I then returned the weapon to Evans after having him fill out and sign a standard Missouri Capitol Police Found Property Receipt. Nothing further at this time.

On 9/20/2013, at approximately 10:10 a.m., while dispatching in the Capitol Police Communications Center, Sgt. Brian Quick advised he was responding to a possible concealed carry violation in the Capitol Building, North-West basement area near the escalator.

On 9/20/20213, at approximately10:13 a.m., Sgt. Quick advised that the recovered a handgun in the men's restroom. Sgt. Quick then called the communications center at 10:14 a.m. and advised that the gun is a Kahr CM9 9mm handgun, Serial #102528, and was in a holster. Sgt. Quick added that the handgun was loaded with one in the chamber.

On 9/20/2013, at 10:30 a.m., the handgun was run by serial number through MULES for wants and warrants. No matches were found for this handgun. (See attached) The handgun was boxed and photographed. (See attached)

On 9/20/2013, at 11:06 a.m., I received a phone call in the communication center from House Speaker Tim Jones's Secretary, Lisa Bondurant (573-751-0562), who stated that a staffer had left a handgun in a basement restroom and when they went to retrieve it, it was gone. Lisa identified the staffer as David Evans. I advised Lisa that I would call her back as information was available on the handgun.

On 9/20/2013, at 11:09 a.m., a MULES/NCIC check was performed on David W. Evans, 04/30/1949, Male, White. No wants and warrants were found for Evans, and no indication of a concealed carry permit was observed. A criminal history was also performed on Evans pedigree information with no results. (See attached)

On 9/20/2013, at 11:10 a.m., House Speaker Jones's Secretary Lisa Bondurant called into the communications center to see if House Staffer David Evans should come to our office to claim the weapon. I advised Lisa that I was still in the process of getting all the information and would call her as soon as possible. Lisa confirmed that Evans is a House of Representatives employee in Room B32 of the Capitol Building.

On 9/20/2013, at 11:16 a.m., I contacted the Missouri State Highway Patrol, Troop F Communications Center inquiring on running subjects for Concealed Carry Permits. I spoke with Communications Operator Brian Pollitt, who advised that the Sheriff's Association has created a website for this purpose. He advised he would check the person for me, Evans pedigree information was given to Pollitt. Pollitt advised that Evans had a valid concealed carry permit, valid until 2016. (See attached)

On 9/20/2013, at approximately 11:55 a.m., the box containing the handgun, ammunition, magazine and holster was given to Sgt. Quick to release to the owner. A property receipt was also completed and given to Sgt. Quick to have the owner sign when released.

On 9/20/2013, at approximately 12:20 a.m., Sgt. Quick returned the signed property receipt to the communications center. (See attached) Sgt. Quick further added that Evans describe the items by brand, caliber, color, size, holster and ammunition count.
